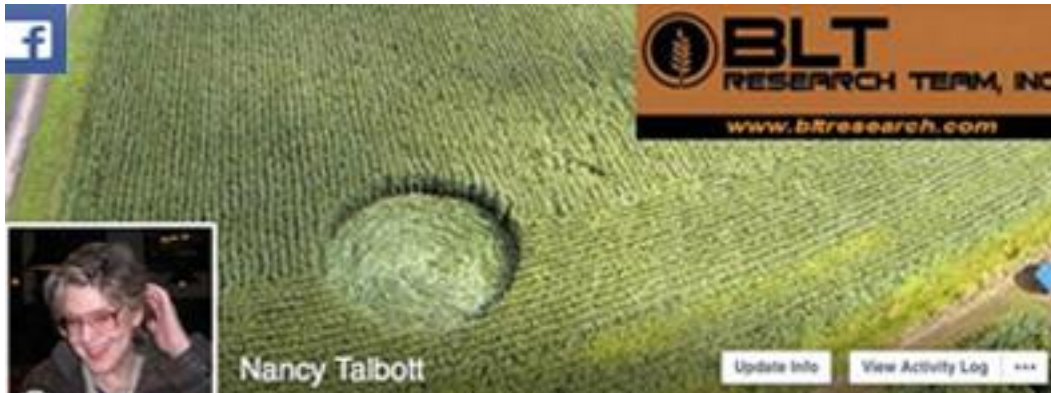


AUGUST, 2016 - FACEBOOK REMOVES NANCY'S FB PAGE, WITH NO EXPLANATION

Placement of August 18, 2013 maize (corn) circle in Hoeven, Holland illustrates precision often seen in genuine phenomenon.

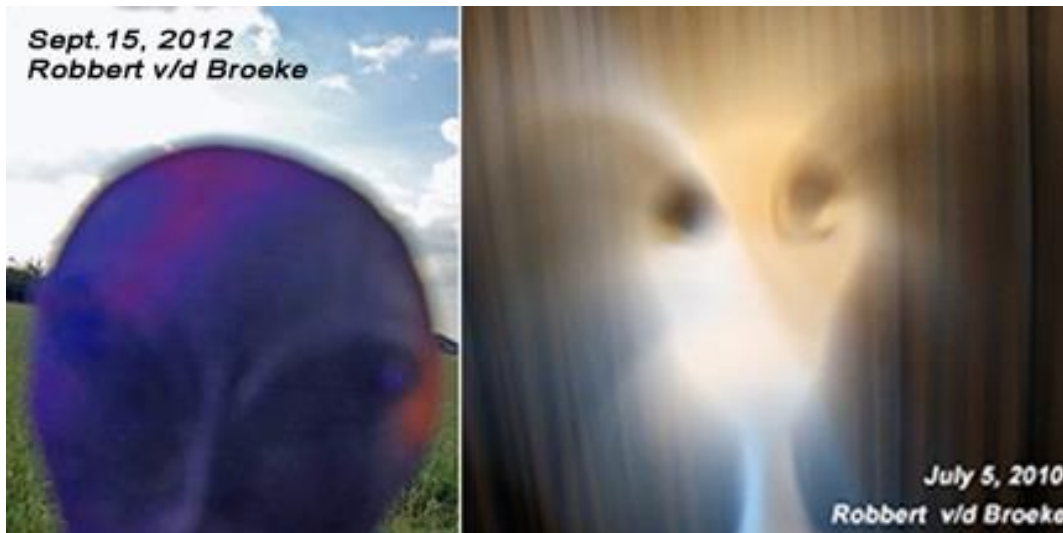
I started my FB page in May, 2015 partly due to lack of funds to pay BLT's (www.blresearch.com) webmaster to post new information and partly in the hopes of broadening the public currently being reached by other means. Specifically, I hoped that by repeatedly providing the scientifically-derived (and peer-reviewed) information regarding the crop circle plant and soil

abnormalities to a new audience I might re-invigorate a more serious interest and investigation into the true nature of the phenomenon.

I also hoped to encourage interest in my increasing certainty, based largely on solid evidence from my work with Dutch “medium” Robbert v/d Broeke (www.blresearch.com/robbert.php), that crop circles are just one of many other so-called “anomalous” events—just one aspect of many individually-labeled and not-yet-understood “bits and pieces” related to either currently unrecognized capabilities or potentials of human consciousness...or the possible existence of unknown external consciousnesses.

BLT professional consultants have carried out quite a bit of “mainstream” scientific analysis as well as professional photo and video analysis in the v/d Broeke case, supporting it’s authenticity and highly anomalous nature, leaving no doubt that events we do not yet understand can, and do, occur.

On Aug.12th I posted on Facebook the report about Robbert's August 10, 2016 videotaping of a brilliant yellowish light-ball descending to a field in Hoeven, Holland, after which he found a new, small "satellite" crop circle-- in broad daylight. Because it was late afternoon Robbert's body could be seen silhouetted against the field during the entire presence of the light-ball.

Then on Aug. 13th I made a new post about Laurance Rockefeller having sent, many years ago, a copy of BLT's major study (the "XRD Clay Mineral Study of Crop Circle Soils") which he had financed, as well as a copy of a report Mr. Rockefeller had asked me to write for him about Robbert v/d Broeke, to Dr. John H. Gibbons, advisor to the State Dept. Within hours of THIS post Facebook removed my FB pg, with no warning or explanation.


Here's the text that accompanied my final FB post:

"Almost no one knows that, upon the completion of the BLT Research Team's Clay Mineral XRD study (www.bltresearch.com/xrd.php), financed by NY philanthropist Laurance Rockefeller, Rockefeller sent a copy of that report to Oak Ridge physicist & member of the National Security Council Dr. John H. Gibbons, previous Director of the White House Office of Science and Technology and assistant to President Bill Clinton for science and technology. Nor that Rockefeller subsequently asked me to prepare a detailed report on my work with Dutch medium Robbert van den Broeke (www.bltresearch.com/robbert.php) which he subsequently also sent to Dr. Gibbons—who by then served as an adviser to the State Department."

"The fact that both of these reports were received, and read, by Dr. Gibbons and are now apparently filed somewhere in the U.S. gov't archives of the White House Office of Science & Technology suggests to me that the U.S. government takes such matters as crop circles and the "medium"

When I emailed FB to find out why my FB page had disappeared I got a form letter back saying they could not help me until they could confirm I was the owner of this account. I subsequently sent them 3 pieces of I.D., after each of which I received the same form letter asking for I.D.—and after my 4th and final try received a form letter reiterating they could not “help me” without I.D. and, further, that my “Case” was “Closed.”



August 14, 2016 – FB’s final form letter to NT, again stating they can’t “help me” without I.D. & also indicating my “Case” was “CLOSED.”

I was given no warning of any kind and have been unable to get any info as to why FB did this. In their list of “rules” posted on FB’s site they DO say they can shut down people’s FB pages for “severe violations” of FB rules--none of which, to the best of my knowledge, I’ve broken.

I feel badly for my many very nice FB “friends,” a number of whom are now emailing me asking me if I have “blocked” them for some reason. I have no way to reach many of these people since I never got their email addresses, so am hoping that this BLT report and other interested parties will make public the facts, so my FB “friends” do not feel arbitrarily abandoned.

For the time-being I’m trying to raise money to pay the BLT webmaster to continue to post new info on the BLT website (www.bltresearch.com) and will do my best to keep the interested public informed of ongoing discoveries and events.
